### LAWN IRRIGATION

#### APPLICATION SUBMITTALS

**LAWN IRRIGATION** requires submittal of the following:

1. Completed Building Permit Application.
2. The permit fee is \$50.50. Make checks payable to City of Aurora.
3. A **Site Plan** showing locations of all yard sprinkler heads. **Please Note: Sprinkler heads are prohibited in the City Right-of-Way curb lawn.**
4. Approvals necessary prior to issuance of a permit:
  - a. Site Plan Review
5. All contractors/subcontractors must be registered with the Planning, Zoning & Building Division. The backflow prevention device must be installed by a state certified plumber or certified backflow installer.
6. Inspections required:
  - a. Final Inspection – Building Inspector will inspect the installation of the backflow prevention device.

**NOTE:** Backflow prevention device must be tested yearly by certified contractor and submitted to the Aurora Water Department. If you should have any questions about the installation of a second water meter for outside water use, please contact the Water Department at 330-995-9109.


